Instuction for authors

Reviewed proceedings will include only empirical studies that:

- Have not been published yet.
- Have proper citations and bibliographical references according to relevant standards (examples below).
- Are processed in accordance with the objectives and requirement of the conference organizers.
- The maximum range of one paper is 5 pages (excluding bibliographical references), ie. 14,000 characters, including spaces, and max. 3 tables or figures.
- The collection will be published the full text of posts.
- The contribution will be emailed to the address conference@post.cz to 15 June 2016 and their authors will quickly respond to comments from reviewers.
- Text that does not comply with the form and the content will not be admitted to the conference program and to the reviewed proceedings.

The Scientific Committee will accept only one contribution from each registered participant because of capacity reasons. Every contribution has to be presented by its author.

Structure of the contribution

- Use MS Word, Times New Roman font, font size 12, line spacing 1.
- Do not segment words, do not end the row with Enter key (only paragraphs), do not indent the first line of a paragraph, write with automatic (black) colour, limit the using of shortcuts - the first shortcut always explain.

The own structure

- First line - the title of the lecture **CAPITALS** (concise and Bold)
- Second line - skip
- Third row - **full name** without titles (Bold)
- Fourth row - *the author's workplace (in italics): workplace differentiate numerically (superscript).*
- Fifth line - skip
- Sixth line - own text under this structure:
